We need your commitment **NOW** for our Summer Camp outing. Please complete the information below and return this form, with your early-bird payment in full or initial deposit, during any of the Monday night Troop meetings in February.

The Early-Bird fee for 2011 will be **\$220.00**. This fee covers the basic camp fee (\$205.00), Wednesday night in-camp dinner (\$8.00) and this year’s Troop t-shirt (\$7.00). Please note that other fees may exist at camp for merit badges and/or other activities chosen individually by your Scout.

If your Scout decides not to attend this outing, please understand that you will still be liable for the non-refundable reservation fees that have been paid by Troop 69 on behalf of your Scout. These fees are not recoverable from the Council.

A **mandatory** Pre-Camp Swim Test for all Troop 69 Scouts and a **mandatory** Parents’ Meeting will be scheduled in May or June during a regular Monday night Troop meeting. We will notify everyone of the scheduled time and place once it’s been decided.
